February 2024 Administrative Charges**

Dear Mr. Johnston:

Baltimore Gas and Electric Company (BGE or the Company) files herewith Supplement 708 to P.S.C. Md. E-6, BGE's Retail Electric Service Tariff, to become effective February 1, 2024.

Based on results from the October 16, 2023 retail supply procurement auction, the Residential, Type I and Electric Vehicle TOU SOS Energy rates have been shaped by rating period using historical summer settlement data. The Residential and Type I standard and unshaped TOU rates were previously accepted by the Maryland Public Service Commission in Order No. 90850, issued October 20, 2023, in Case Nos. 9056 and 9064.

Under Rider 1, the SOS Administrative Charges are subject to adjustment in the February, June and October billing months to reflect the estimated incremental, uncollectible, and cash working capital costs of providing Residential, Type I, Type II and Hourly Service. The Company has performed its true-up of actual incremental, uncollectible, and cash working capital costs to the estimated costs of providing Residential, Type I, Type II and Hourly Service. As such, any over- or under-collection of costs compared to the estimated costs for the program year are included in the projected Rider 1 rates herein to be effective for the period from February 2024 through May 2024.

Under Rider 1, the SOS Administrative Charges are also subject to an annual adjustment to the return component. Effective for the period from February 2024 through January 2025, the Company has adjusted the return component by service type consistent with Commission Order No. 87891 in Case No. 9221. The Return calculation reflects the rate of return awarded by the Commission in Order No. 90948 in Case No. 9692. See Attachment 1 for supporting calculations.

With this filing, the total SOS Administrative Charges for Residential, Type I and Type II, and Hourly Service will change effective with February 2024 bills from 3.94 mills per kWh, 3.24

mills per kWh, 3.37 mills per kWh, and 2.60 mills per kWh to 4.06 mills per kWh, 4.63 mills per kWh, 4.32 mills per kWh and 2.30 mills per kWh, respectively. The individual proposed components of BGE's Administrative Charge for Residential, Type I, Type II and Hourly Service customers are shown below.
